PAYMENT SCHEDULE

The following is the payment schedule of Tuition Fee, Hostel, Transport Fee and Other Charges. The dues will be paid in four installments.

1. **FIRST Installment** with all other charges will be paid at the time of Admission.
2. **SECOND, THIRD and FOURTH Installment** will be paid in the month of September following the date of Admission.
3. Last date for payment will be before the start of third, fifth and seventh Semester Classes. A late fee of Rs. 5000/- p.m. will be charged and the student will not be registered for next Semester or UET Peshawar Examination until he pays his full outstanding amount with late fee.
4. Other charges of UET Peshawar will be payable by students to the UET like Transcript, Rechecking fee, Degree fee etc.
